ACT 25 OF 1999).**

The above matter was discussed at the meeting of the Inventories, Grading and Interpretation Committee (IGIC) of Heritage Western Cape held on **7 February 2020**.

In the IGIC meeting it was noted that:

In terms of the due process as prescribed in terms of Section 27(8)(b)(c) of the National Heritage Resources Act (NHRA, Act 25 of 1999) all Interested & Affected Parties should be notified. This letter is therefore sent to you to inform you that the above site is proposed to be proclaimed as a Provincial Heritage Site in terms of Section 27(7)(b) of the NHRA, Act 25 of 1999.

You are allowed 60 days in terms of Section 27(8) in order to make submissions regarding the proposed proclamation and in the case of being the landowner, to propose conditions under which the action will be acceptable.

Please address all submissions to the official mentioned above, **within 60 days** of this notification. The documentation is attached for your perusal.
